UPDATE ON ADVANCE PASSENGER INFORMATION AND PASSENGER NAME RECORD (API/PNR) FEE

This AIC is issued pursuant to Section 59 of the Kenya Citizenship and Immigration Act 2011, the cabinet secretary for interior and National Administration has levied charges and fees on the services offered by the State Department for Immigration and Citizen Services **effective 1st January 2025** as shown in the schedule below:

Further, all carriers and general aviation operators are informed to comply by integrating their payment systems with the service provider, Société Internationale de Télécommunications Aéronautiques (SITA), by 01 December 2025.

The purpose of this fee is to defray the costs associated with capturing, transmitting, processing, and administering API/PNR data under the national framework. The fee will apply uniformly across all Kenyan airports to all international flights (arrivals, departures and transit passengers).
